



FY2014 Omnibus Bill Northeast-Midwest Region Priorities

On Monday, January 13, 2014, the House and Senate Appropriators released the [FY2014 Omnibus Bill](#) for consideration. The House is scheduled to vote on the bill on Wednesday, January 15, and the Senate is due to take up the bill before the coming weekend.

The Northeast-Midwest Institute has compiled a brief chart of regional priorities and their funding levels within the Omnibus Bill. Not all programs, normally listed in the NEMWI's Budget Day Briefing Document are included, as further details are not yet available. The NEMWI will update this document once additional program funding levels are known.
