Great Lakes Restoration Initiative (GLRI)

- Built upon the foundation of the Great Lakes Regional Collaboration Strategy,
 GLRI answered a challenge of the governors of the Great Lakes states.
- GLRI is guided by an Action Plan, the Federal agencies of the GLRI's Regional Working Group coordinate to select the best combination of programs, projects, and activities to achieve GLRI goals.
- First implemented through the FY 2010 Interior and Continuing Appropriations Act.
- In December of 2016, Congress amended Clean Water Act Section 118, to include authorization of the GLRI in the amount of \$300 million annually for fiscal years 2017 through 2021 and the direction to address five priority areas.
- Federal agencies do the work of the GLRI guided by five-year Action Plans, developed with input from states, tribes, local governments, universities, business and others:
 - GLRI Action Plan 1 (2010-2014)
 - GLRI Action Plan 2 (2015-2019)
 - GLRI Action Plan 3 (2020-2024) currently a draft



Five Focus Areas

- Toxic substances and Areas of Concern;
- Invasive species like Asian carp;
- Nearshore health and nonpoint source pollution;
- Habitat and wildlife protection and restoration; and
- Accountability, monitoring, evaluation, communication, and partnerships.
